2. The Commission may co-opt the Head of a Department where the Commission may be called upon to exercise powers and functions under the said Act in respect of that Department.
3. The Commission may also hold hearings at any other place as may be considered necessary in the course of performing its functions under the Act.
4. The Commission, by notification, may adopt regulation of procedure as may be considered necessary for performing its functions.
5. The Commission shall exercise the powers and perform functions as provided under Section 4 of the Act.
6. The Commission shall also consider the need of any particular Department having Work Charged establishment for creation of limited number of posts as part of the scheme for regularisation as contemplated in Section 12 of the Act and shall submit its report and recommendation in this regard.
7. The Commission shall submit its report and recommendation as expeditiously as may be considered reasonable to the concerned Departments for obtaining the approval of the Cabinet.


