**OFFICE MEMORANDUM**

Dated Kohima, the 29<sup>th</sup> July, 2009.

**No.AR-3/Gen-199/99** : : In the interest of public services, the Governor of Nagaland is pleased to order the creation of a new Department of New & Renewable Energy (NRE) with immediate effect.

2. The new Department shall function under a separate Minister and Secretary at the Secretariat level, to be supported by the required officers and staff of the Secretariat. All other officers and staffs who are presently posted in IREP, NBMMP, NREDA shall continue to be on deputation to the new Department under the same terms and conditions and shall form the core group for the new Directorate of NRE.

3. The Directorate of the Department of NRE shall continue to function in the RD Directorate building till an alternative arrangement is made.

4. For implementation of any hydro-electric power project, the Department of NRE shall be responsible for taking up projects of 1MW capacity and below. However, Power Department and NEPeD shall also continue to have jurisdictions to implement hydro-power projects of 1MW capacity and below. In order to co-ordinate the various hydro-projects of 1MW capacity and below that may be taken up by Power Department, NRE Department and NEPeD, there will be a Standing Co-ordination Committee consisting of the following:
