OFFICE MEMORANDUM

Dated, Kohima, the 8th December, 2008

No. AR-3/Gen-147/2005: : In exercise of the powers conferred on the State Government under Section 16(5) of the Right to Information Act, 2005, the detailed terms of condition of service of **Information Commissioners** are as follows.

Tenure: The Information Commissioners shall hold office for term of 5 (five) years or till he attains the age of 65 years or which ever is earlier.

Pay and allowances:

(i) The Information Commissioners shall draw a pay of Rs. 26,000 p.m. (Fixed). If he is in receipt of pension (other than a disability or wound pension) from Government of India or from State Government, his salary as Information Commissioners shall, be reduced by the amount of that pension including commuted portion of pension. If he is in receipt of retirement benefits in respect of any previous service rendered in a Corporation established by or under any Central Act or State Act or a Government Company owned or controlled by the Central Government or the State Governments, his salary in respect of the service as Information Commissioner shall be reduced by the amount of pension equivalent to the retirement benefits.

(ii) Dearness Allowances & Dearness Pay as admissible to All India Service Officers on monthly remuneration before reduction.

(iii) The Information Commissioners shall not be eligible for Dearness Allowance on service pension during his tenure.

Sumptuary Allowance: A monthly sumptuary allowance as admissible to the Chief Secretary, Nagaland shall be admissible to the Information Commissioners i.e Rs 350/- (Rupees Three Hundred and Fifty only) per month.

Leave: The Information Commissioners shall be entitled for any kind of leave as applicable to a member of All India Service Officers.

LTC : The Information Commissioners shall be eligible for LTC applicable to a member of All India Service Officers

Accommodation: The Information Commissioners shall be eligible for Government accommodation on par with the Chief Secretary, Nagaland. Where, for any reason, the accommodation is not provided by the Government, he may be paid every month an allowance equivalent to an amount of 7.5% of his pay plus dearness pay as HRA in lieu of rent-free official residence.

Medical facilities: The Information Commissioners and the dependent members of their families shall be entitled to such facilities for medical treatment and for accommodation in hospitals as applicable to a member of All India Service Officers from time to time.

Conveyance facilities : The Information Commissioners shall be entitled to a staff car and 100 litres fuel per month or the actual consumption of fuel, whichever is less.

Telephones : The Information Commissioners shall be provided with telephones one at office and another at residence with STD facility with a ceiling of not more than Rs 5,000/- p.m.


